#### **AVAILABILITY**

Available to consumers of the Cooperative located on its lines for homes, churches, schools, community houses, and general farm uses including lighting, incidental appliances, refrigeration, cooking, heating, air conditioning, and power for motors up to and including ten horsepower, or a total connected motor load not in excess of fifteen horsepower; all subject to the established rules and regulations of the Cooperative.

This rate shall be subject to the terms and conditions set forth in the AGREEMENT TO PURCHASE ELECTRICITY.

## **CHARACTER OF SERVICE**

Single-phase at standard available voltage.

#### **NET MONTHLY RATE**

Service Charge: \$1.30 per day

Energy Charge:

18.190 cents per kWh for all On-Peak kWh, plus 6.419 cents per kWh for all Off-Peak kWh.

#### **DETERMINATION OF BILLING ENERGY**

The billing energy shall be the energy measured during the monthly billing period. The On-Peak kWh shall be the kWh measured during the On-Peak hours. The Off-Peak kWh shall be the kWh measured during all other hours.

## **PEAK PERIOD HOURS**

The On-Peak period hours include all weekends and holidays. Off-Peak period hours shall be all hours not in the On-Peak period.

#### **Summer On-Peak Period (May – October)**

Hour beginning at 3 p.m. through hour ending at 8 p.m.

# Winter On-Peak Period (November – April)

Hour beginning at 6 a.m. through hour ending at 8 a.m., and Hour beginning at 5 p.m. through hour ending at 8 p.m.

# MINIMUM CHARGE

The minimum charge shall be the service charge multiplied by the number of days in the billing cycle.

# TAX CLAUSE

Billings under this rate shall be subject to the Mississippi state and municipal sales taxes and any new or additional taxes imposed upon the Cooperative by any governmental authority after the effective date of this schedule. If these new or additional taxes are allocable to the consumer on a per meter or per kWh basis, they will be added to the bill rendered hereunder directly on the same basis. If, however, the new or additional taxes are not allocable directly, then the total of such taxes paid during the preceding year will be divided by the total kWh sold during the preceding year and all kWh billed under this schedule will be adjusted by the amount thus derived.

#### TERMS OF PAYMENT

In the event the current monthly bill is not paid on or before the due date, a delinquent fee will be added.

# **ENVIRONMENTAL COMPLIANCE CHARGE**

To the above charges for electrical service rendered under this rate schedule, there shall be added an amount per kWh, based upon the Environmental Compliance Charge of the Cooperative's wholesale power supplier.

If the Environmental Compliance Charge per kilowatt-hour (kWh) of power purchased by the Cooperative changes from the base cost of 2.87 mills per kWh, the Cooperative may increase or decrease its rate by an amount sufficient to compensate for the change.

#### **COST OF POWER ADJUSTMENT**

If the cost per kilowatt-hour (kWh) of purchased power to the Cooperative changes from the base cost embedded in the Cooperative's rates, the Cooperative may increase or decrease its retail rates by an amount sufficient to compensate for the change.
