CEO WELCOME

WELCOME TO OUR 2022 MEMBERSHIP MEETING

As a relative newcomer to a distribution cooperative, I have enjoyed learning the ropes, working with employees, and absorbing the wisdom of our board during some trying but rewarding months. Alongside what we consider recurring challenges, we have faced supply chain shortages as never before. Legislative mandates and political actions have left us to determine the best courses of action to protect Southern Pine, and our members, from burdensome requirements and prohibitive costs.



While preparing to write this report and focusing on the positive work we have accomplished, I think of our employees' dedication and hard work. As always, the safety of all employees is paramount. Our safety record is a testimony to the diligence of our safety and training departments and employees who work safely, reduce accidents, and return to their families at the end of the workday.

No one needs a reminder of the financial challenges all of us have encountered in 2022. Everything

is more expensive and we must still care for our families and businesses. Despite that, I am pleased to report that Southern Pine is financially sound and prepared to meet unforeseen contingencies.

High electricity demands due to weather events, higher consumption from ever-increasing technological needs and devices, and extreme weather conditions, have tested the infrastructure and amplified the need for upgrades in several areas. To keep pace with demand and improve reliability, we have significantly enhanced existing substation sites and equipment over the year. That, together with an aggressive right-of-way clearing plan, has helped improve system outage times and service to members. The call center implementation has reduced telephone hold times, and a new text option provides greater flexibility when reporting outages. The addition of collection notifications via text has resulted in fewer disconnects and better member satisfaction. By this time next year, we hope to have payment kiosks available for the convenience of our members.

Though providing electricity is our business, we are always active in economic development that benefits members and our region. We support our local newspapers, media partners, blood banks, law enforcement

agencies, and emergency response personnel throughout our eleven-county area. Other programs for the benefit of members are the National Cooperative Day of Service, Cold Feet Hurt, Pennies for Power, Adopt-a-School, Member Circle, energy and conservation fairs, home audits, safety demonstrations, food drives, and work at community and school events. In addition, we provide Today in Mississippi magazine for all members. The magazine is a timely way we can communicate with members, particularly those who are not engaged on social media.

As we conclude another year at Southern Pine, I think of the wisdom in Helen Keller's words when she said, "that alone we can do so little, but together we can do so much." Those words exemplify what it means to be an electric cooperative and work together toward a shared vision.

I am excited to see what the new year holds for us and ask God's blessings on our employees, directors, and you, our members.

RIGHT-OF-WAY CLEARING

With over 10,500 miles of energized lines spanning 11 counties, vegetation management is a continuous cycle. In the first eight months of 2022, over 2,000 miles have been cleared. We anticipate clearing another 800 miles by the end of 2022. This year we have 20 trimming machines working on our system. This right-of-way maintenance allows Southern Pine to quickly restore service to our members during all outages but is critical to restoring power during significant storm events.



CALL CENTER

Our members deserve to reach Southern Pine when they need us. With that in mind, we opened a new member service call center in spring 2022. Staffed with dedicated local employees, the call center operates in headquarters in Taylorsville. These employees know Southern Pine and our members and have the knowledge and skills to help you. Since implementing the call center, representatives have helped more than 50,000 members.

MYPOWER QUICK PAY

You asked for it, and we heard you. When we changed payment service providers in 2021, the one-time payment option was unavailable. Through diligently working with the current vendor, we are happy to report that MyPower Quick Pay is now available at southernpine.coop. It's quick and easy, and all you need is your account number and the last four digits of the phone number associated with the account. Once you verify the account is correct based on the address listed, you can proceed with making a payment.



TEXTING FOR OUTAGES

In 2022, Southern Pine added a new service for our members – texting for outages. It has been a great success and is an easy and convenient way to report outages quickly. Southern Pine can also text a specific group of members if planned maintenance is scheduled in a particular area that will require an outage. To take advantage of texting, please make sure your cell phone information is listed on your account.

SAFETY DEMONSTRATIONS

Southern Pine's highly-trained safety team is available for electric safety demonstrations at schools, businesses, or community events. Electrical education, and the commitment to always put safety first, ensures that our men and women return home each day to their families and loved ones.



COOPERATIVE DAY OF SERVICE

As we commemorate the legacy of Dr. Martin Luther King, Jr. each January, Southern Pine participates in Cooperative Day of Service. Our employees volunteer with local agencies in need of help. This year we volunteered to do some renovations at Hope Recovery Center and Piney Woods School. Another group participated in highway cleanup and beautification projects.



STUFF-A-TRUCK FOOD DRIVES

Through Stuff-a-Truck food drives, we help local food pantries stock their shelves. We don't want anyone to go hungry when we're here to help. Our members and employees have really shown their giving spirit and kindness during these drives, filling up trucks with food to help those needing a hands-up.



MEMBER CIRCLE

We love getting together with our members and hearing what you have to say, so every quarter we host a Member Circle in a different county. This time of food, fellowship, and feedback is a perfect opportunity for our members to learn what is going on at Southern Pine and to let us know of what you think. We want to hear from you!



JOINT COOPERATIVE MEDIA DAY

Southern Pine, along with several sister co-ops, hosts Joint Cooperative Media Day in May to meet with our media partners. The day includes a roundtable discussion, speakers, and a meet and greet. Media partners play a critical role in disseminating information to members, especially during severe weather events. We want to make sure they have the facts needed to communicate with members.



COLD FEET HURT

Socks are the most requested item from local nursing homes and shelters, so we fill some of that need through Cold Feet Hurt. Employees, members, and directors donate hundreds of pairs of socks, and then we deliver them within our service territory, along with other items they may need. It may seem like a small gesture, but to many, a pair of clean, warm socks, can brighten their day.



PENNIES FOR POWER

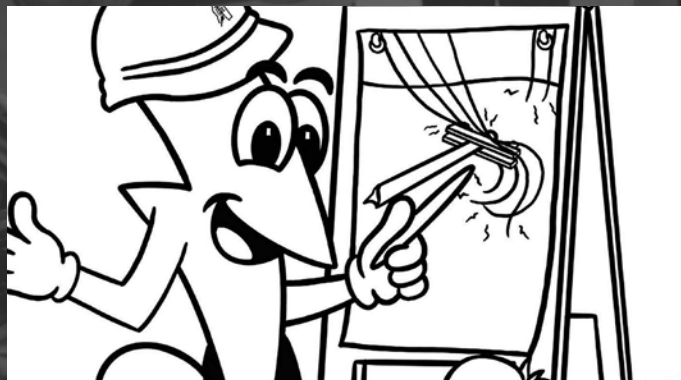


COOPERATIVE UNIVERSITY & YOUTH TOUR

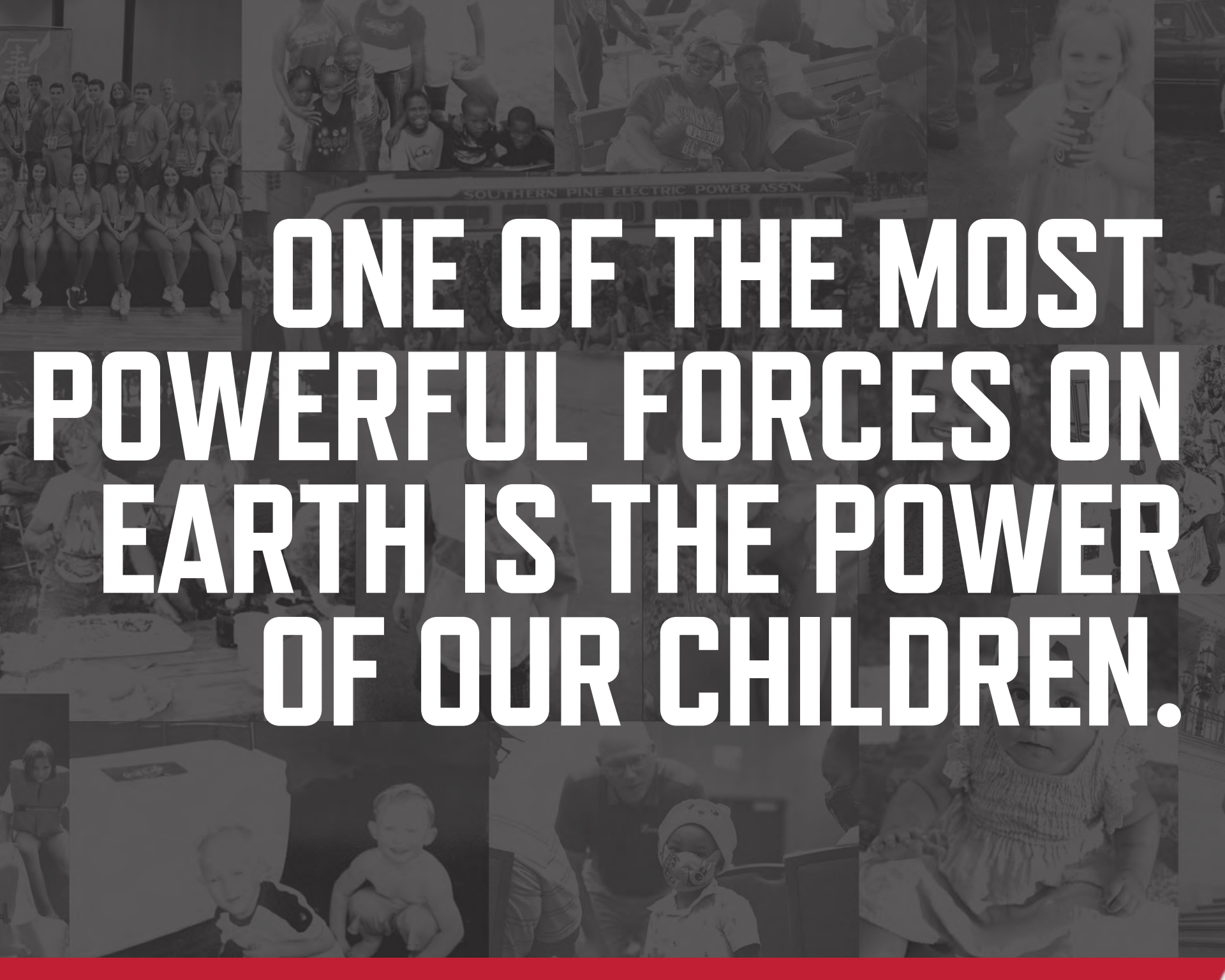
STUDENT AMBASSADOR

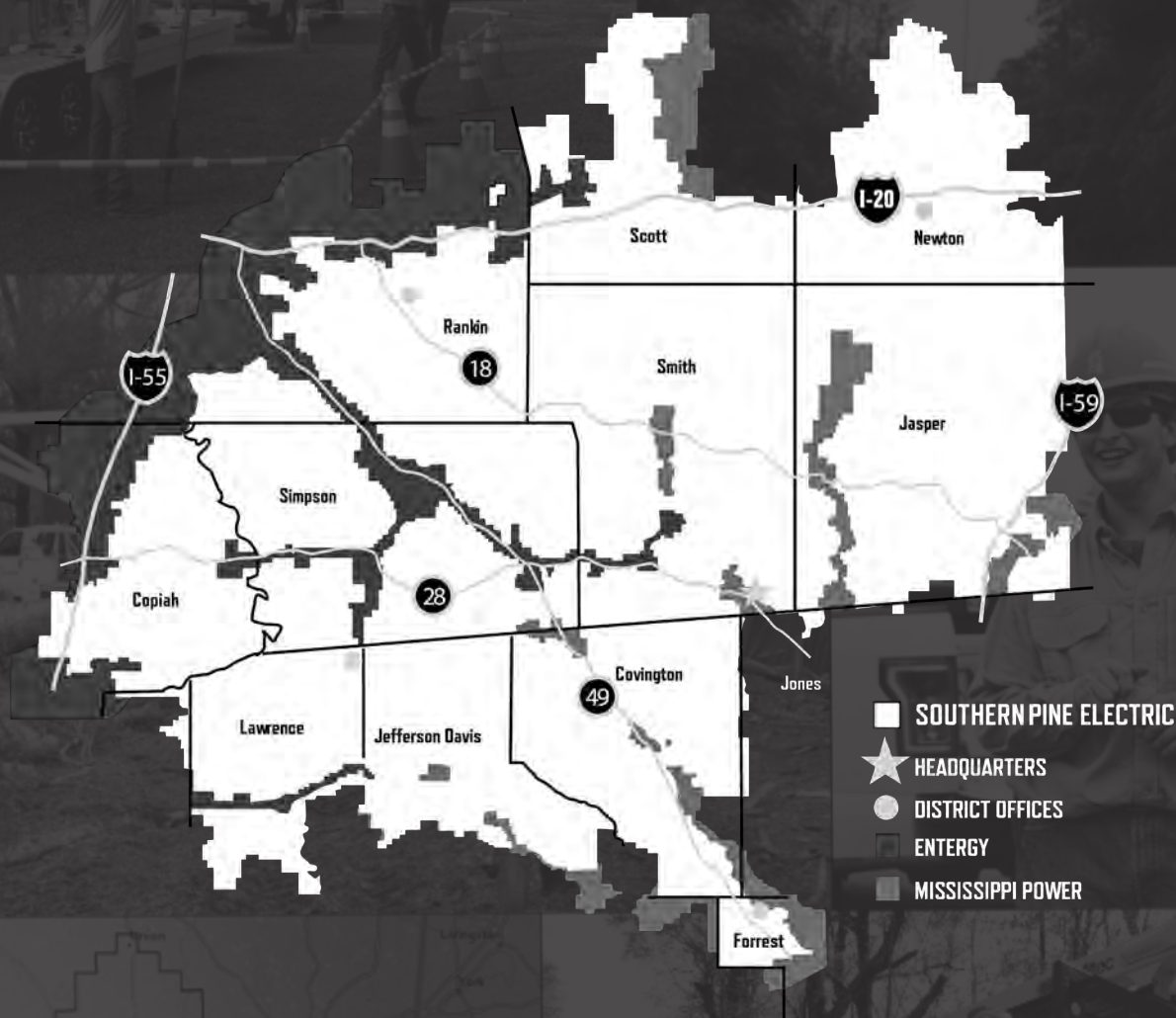
